Fire Safety:

Residents are responsible for ensuring their premises comply with all applicable fire and life safety standards. For further information regarding fire safety, please visit: www.HuntSafetyZone.com.

Portable fire pits or chimneys are allowed with the following conditions:

- Tenants cannot construct or use non-commercial fire-burning equipment.
- Adequate insurance is required to cover potential damages or injuries.
- Follow all state, county, local, and military regulations.
- Usage is prohibited during burn bans.
- Must follow manufacturer's instructions, and hours of use may be set by the Community Management Office.
- Use is restricted to backyards only; not allowed in common areas or front/side yards.
- Fires must be small (max 3ft in diameter) and constantly attended by an adult.
- Maintain a 15-foot clearance from structures or combustible materials.
- Keep a fire extinguisher, garden hose, or water bucket nearby.
- Use only noncombustible flat surfaces.
- Do not use accelerants or burn trash, painted wood, or debris.
- Prohibited during winds over 10mph or if smoke disrupts neighbors.
- Store firepits or equipment in the garage, carport, or back patio after cooling.
- Firewood must be stored at least 22 ft from buildings and not inside the home.

Ash Disposal:

- Wait at least 24 hours after extinguishing the fire before handling ashes.
- Use a metal shovel and transfer ashes to a metal ash bucket.
- Never dispose of ashes in a trash can.

Barbeque Grills:

- Grills must be at least 10 ft from the house or fence.
- Never leave grills unattended while in use or hot.
- Dispose of ashes only when completely cool.
- Cooking in front yards or on covered patios is prohibited.
